
FY24 <u>Awards</u> Moving Forward– Summary

- \$2,490,000 invested with \$40,798,407 leveraged
- \$1 invested = \$17.38 in affordable housing


- \$540,000 (22%) for 14 households with incomes below 30% AMI (supported rental)
- \$1,650,000 (66%) for 170 households with incomes below 60% AMI (rental)
- \$300,000 (12%) for two households with incomes below 80% AMI (homeownership)
